Dear Comrade,

### **23<sup>rd</sup> All India Conference**

You are all aware that 23<sup>rd</sup> all India Conference of our beloved Association, UCBEA, is scheduled to be held at Patna, Bihar on 24<sup>th</sup> & 25<sup>th</sup> February, 2024. Our Bihar State Unit is organising the Conference befittingly upholding our traditions and practices.

It has been decided in the meeting of the Office Bearers of our Association to name the City of Patna during the Conference as "**Hrushikesh Mohanty Nagar**", the Auditorium be renamed as "**Ravi Ahuja Hall**", Manch renamed as "**Dayal Chandra Dey Manch**" and Podium as "**Subir Kumar Dey Podium**".

Thus the 23<sup>rd</sup> All India Conference of our Association will be held, as was decided in last CEC Meeting, at Patna (Hrushikesh Mohanty Nagar), Bihar with due pomp and grandeur. Our attempt will be to utilise both days fully ensuring better participation and proper use of time. It has further been decided to start the Conference on 24<sup>th</sup> February 2024 morning. Our earlier decision was to hold the Conference by participation of Delegates and other Participants viz. Honorary Members, present CEC members and Advisers. In course of Office Bearers' meeting, based on suggestions, it was also decided to include Observers from the working employees depending upon the requirement of the States and not exceeding 50% of the strength of Delegates from the States. State Secretaries and Presidents were already informed about this development and now we request them to send the list of Delegates & Observers including the name of the Participants who will participate in the forthcoming All India Conference of our Association. This is of top priority as depending upon the number of total participants, we have to arrange for food and lodging in **Hrushikesh Mohanty Nagar (Patna)**.

Comrades, you are aware that Delegation Fee per head (Delegate, Observer, Honorary Member & other Participants) had been decided at Rs.2,000/-. A contribution of Rs.200/- per member is also payable by the State Committee towards the All India Conference. We, therefore, request all concerned to cooperate in the matter and **State Secretaries must send us the list of total participants from each State, remit the subscription upto December 2023 latest by 15<sup>th</sup> January 2024 and remit the contribution (@Rs.200/- per member) and Delegation Fee @Rs.2000/- per Participant latest by 31<sup>st</sup> January 2024.**

### **Other Issues**


