## **Full text of BEFI Circular No.32/2025 dated 23.06.2025**

### **Quote**

Apropos to the decision of the Joint Platform of Central Trade Unions and independent sectoral Federations/Associations rescheduling the General Strike from 20 May 2025 to 9 July 2025, Notice have been served on 20 June 2025 to the appropriate authorities by 3 Organisations jointly including BEFI for observing Strike in Banks throughout the nation on 9 July 2025 on the following demands:

- **Strengthen Public Sector Banks and Insurance Companies**
- **Stop privatisation and disinvestment in Banks and LIC**
- **Stop 100% FDI Hike in Insurance**
- **Merge Public Sector General Insurance Companies as one entity**
- **Ensure adequate recruitments**
- **Stop outsourcing and contract jobs**
- **Scrap NPS – Restore OPS**
- **Take tough measures to recover bad loans from Corporates**
- **Reduce service charges in Banks for ordinary customers**
- **Withdraw GST on life and health insurance premiums**
- **Do not impose retrograde Labour Codes**
- **Do not infringe upon trade union rights**
