Full text of BEFI Circular No.33/2025 dated 25.06.2025

Quote

The working class of the country is preparing for observing 23rd nationwide General Strike on 9 July 2025 to oppose the anti-worker, anti-farmer, anti-people, anti-nation policies of the ruling NDA government at the centre. The National Convention of Workers have decided to observe the Strike on 17-point demands related with all sections of people. In financial sectors, six national level Organization of bank and insurance, will observe the Strike on 9 July 2025 on demands pertaining to sector specific issues along with 17-point demands.

We understand that all the issues are quite relevant and important. The focus of the demands is centering around the four Labour Codes, which, the central government is desperate to implement to impose slavery on the working class of the country with ultimate aim to satisfy its corporate friends for maximizing their profits in the coming days. On behalf of BEFI, we provided 'Talking Points on Labour Codes' during our extended General Council meeting at Patna on 1-2 March 2025. Subsequently, we issued an exclusive Booklet on Labour Codes which was later translated in vernacular by some of the State Federations. Another brief note on Labour Codes is being prepared for campaign among the employees, required to continue even after the Strike.
