Text of BEFI Circular No.25/2025 dated 03.05.2025

We have already informed that BEFI, along with other organizations, will be observing country wide Bank Strike on 20 May 2025 as per decision of the National Convention of Workers held at New Delhi on 18 March 2025. Some organizations of the Insurance sector, also, will be observing Strike in Insurance on the same day. In an unprecedented development, several national level Federations and Associations of Bank and Insurance sector decided to hold joint campaign programme throughout the country in preparation of the Strike call. Joint Circular and Joint Poster have also being printed with common demands of these two principal financial sectors of our country.

In mutual consultation, it was decided that the Federations and Associations of the banking industry would serve joint Strike Notice for 20 May 2025. Accordingly, Strike Notice was served today, 3rd May 2025, to the appropriate authorities as per Declaration of the National Convention. Text of the Strike Notice is appended. The Strike Notice consists of a list of programme starting today. We call upon our Units and Affiliates to observe all the programme in respective areas along with other two Associations participating in the Strike. In addition, we are to participate in the programme already announced in the Declaration of the National Convention along with the Central Trade Unions and fraternal Federations.

In accordance with the provisions contained in sub-section (1) of Section 22 of the Industrial Dispute Act 1947, we hereby give you notice that employees and officers who are the members of our above mentioned three trade union organisations propose to go on Strike on 20th May, 2025 on the following issues:

DEMANDS

- Strengthen Public Sector Banks and Insurance Companies
- Stop privatisation and disinvestment in Banks and LIC
- Stop 100% FDI Hike in Insurance
- Merge Public Sector General Insurance Companies as one entity
- Ensure adequate recruitments
- Stop outsourcing and contract jobs
- Scrap NPS – Restore OPS
- Take tough measures to recover bad loans from Corporates
- Reduce service charges in Banks for ordinary customers
- Withdraw GST on life and health insurance premiums
- Do not impose retrograde Labour Codes
- Do not infringe upon trade union rights
